# "RAGGING IN ANY FORM INSIDE OR OUTSIDE THE CAMPUS IS BANNED"

Vide Hon'ble Supreme Court of India Orders on SLP (Civil) 24295 and 24296 of 2004-University of Kerala v/s Council, Principals of Colleges, Kerala and others, the senior students who are involved in ragging junior students may be given the following punishment:

FORMS OF RAGGING	PUNISHMENTS
1. To address seniors as 'Sir'	Cancellation of admission.
2. To perform mass drills	Suspension from attending classes.
3. To serve various errands	Withholding/withdrawing scholarship/ fellowship and other benefits.
4. To do menial jobs for the seniors	Debarring from appearing in any test/examination or other evaluation process.
5. To ask/answer vulgar questions	Withholding results.
To look at pornographic pictures to 'Shock' the freshers out of their innocence	Debarring from representing the institute in any national or international meet, tournament, youth festival etc.
7. To force to drink alcohol, scalding tea etc.	Suspension/expulsion from the hostel
8. To force to do acts with sexual overtones	Rustication from the institution for period varying from I to 4 semesters.
To force to do acts which can lead to physical injury/ mental torture or death	Expulsion from the institution and debarring from admission to any other institution.
10. To strip, kill etc.	Fine upto ₹25,000/-
11. To do other obscenities	Rigorous imprisonment up to three years.

While the first 10 types of punishments can be awarded by the appropriate authority of the institution itself, the last punishment can be awarded only by a court of law.

In case any fresh student becomes a victim of ragging by his/her senior/s, the incident should immediately be brought to the notice of the Head/Principal.

#### Guidelines:

- Students who have been placed in the reappear list of PSEB or any other equivalent Board will be given Provisional Admission only.
- Students whose Matric result has been declared late by the Board can take admission in +1 within 15 days of the declaration of the result without any late fee. The attendance of such students shall be counted from the date of admission itself.
- Students who have been placed in the Reappear/Compartment list of the Board are eligible to take admission as a regular student in +1 in any government/affiliated/aided/associated institute as long as its Board is recognized at par with Punjab School Education Board, and they pass the matriculation exam in the next two attempts.
- The Head of the institute can allow change of subject/faculty within a month from the date of admission to the college.
- Regular students who have failed in +2 twice are eligible to take admission in +2 again as a regular student only.
- Regular students who have been placed in the Compartment/reappear list of the Board in +2 but do not wish to avail the benefit of reappear in the examination are free to take admission again in +2 by depositing an affidavit stating that they have got cancelled their last result from the concerned branch of the Board within 30 days of the declaration of the result.
- Regular students from government/aided/affiliated/associated institute who have passed their +1 examination within 3 years counted from the current session are eligible to take admission in +2.
- Students after passing +1 examination can change their subject(s) under the same group.
- Students seeking migration are required to submit to the institute where admission is sought a school leaving certificate from the concerned Board and duly signed and attested by a competent authority or the District Education Officer during the academic session or after passing the examination.
- Students whose name appears in the list of candidates on COBSE and MHRD are not required to submit any certificate stating the equivalence of the two concerned Boards. The result of students from Boards other than PSEB will be duly verified by the concerned institute where he/she is seeking admission. Such student(s) will have to submit to the institute relevant documents such as Migration certificate, DMC, Pass certificate and Transfer certificate duly countersigned by the DEO.
- Students who have done their schooling from some other country and now wish to pursue education under the PSEB or wish to take admission in different courses after passing +2 can do so only after they have submitted an equivalent certificate issued by AIU and after the issuance of equivalence certificate by PSEB.
- Students who have completed a 3 year diploma from Punjab State Board of Technical Education and Industrial Training or a 2 years certificate course from SLIET will be treated at par with students who have passed +2 from PSEB.
- Students who wish to take migration during the academic session of either +1 or +2 can get the migration certificate on the recommendation of both heads of the institutes, and are eligible to take admission in any school at the initial stage provided the registration number appears on the School Leaving Certificate and till the scheduled dates of admission.



Admission to B.A./ B.Sc. (Med. & Non-Med.)/B.Com./B. Com. (Hons)/BBA/BCA/B.Sc. (IT)/B. Sc. Comp. Sci/B.Sc. (Eco.)/Bachelor of Design (Multimedia)/Post Graduate Diploma in Computer Application (PGDCA), Diploma in Comp. Applications (DCA), M.A. (Economics), M.Com. (Finance and Accounts), M.Sc. (Maths) and M.Sc. (Computer Science) is going on and will continue as per University schedule.

# Dates of Admission are yet to be decided by the University

#### N.B. Admission to all classes is subject to availability of seats.

- 1. Applicants for admission must be present at the College with the following documents:
- a) University/Board Certificates and of College last attended by the applicant.
- b) Character Certificate from the Head of the School or College last attended by the applicant.
- c) Aadhaar Card
- d) **Eligibility Certificate** issued by GNDU to the students who have passed their qualifying examination from another institution except from PSEB, Punjab University, Punjabi University and GNDU. For securing Eligibility Certificate, a candidate must apply on a prescribed form with a fee of Rs. 350/- along with the following documents:
  - (i) Original Certificate and DMC of lower class passed.
  - (ii) Original Migration Certificate of the Board/University from where the candidate has passed his/her lower examination.
  - (iii) The last date for obtaining the Eligibility Certificate is as per GNDU guidelines.
- e) SC/ST candidates are to submit certificate from competent authority.
- f) For proficiency in sports/extra-curricular activities, relevant certificates must be submitted.
- Candidates, whose applications for admission are accepted provisionally, shall be considered only when they have paid their dues and have made available to the College office the information that is lacking, and fulfilled the conditions stipulated for regular admission.

# While seeking admission, a student must submit four latest passport size photos along with the admission form, failing which his/her admission would be considered invalid.

- 3. The admission of a candidate shall be deemed valid only if he/she deposits his/her fees and other dues in the College and obtains the Roll Number Slip immediately after the Principal has put his signature on the admission form granting him/her admission.
- 4. Students, whose results are declared late by the University/Board, or who seek admission to technical institutions but do not succeed therein, can join the College within ten days of publication of the results, as the case may be, without the payment of late fee fixed by the University/Board as per rules. This, however, is subject to availability of seats in the College.
- 5. Fees/dues once paid to the College shall not be refunded under any circumstances.
- 6. The Principal reserves with himself the right to grant or refuse admission to any student without assigning any reason thereto.
- 7. Regular students of the College are not allowed to appear in the University Examinations as private candidates.
- 8. Students having passed the lower/qualifying examination through non-formal schemes shall not be allowed to join the next higher class in the College as a regular student.
- 9. No student shall be admitted to the first semester of any under graduate class unless he/she has successfully completed 12 years of schooling from a recognised Board.
- 10. Only the following categories of students shall be allowed to take up Basic Punjabi/PHC in lieu of General Punjabi at the graduate level:
  - a) Non-Resident Indians or Foreign Nationals.
  - b) Those who have passed Matric and/or Senior (+2) Examination with Punjab History and Culture in place of General Punjabi.

- c) Residents of other states of the Union of India whose mother-tongue is not Punjabi and who have not studied Punjabi at any level.
- d) Those who are not domiciles of the State of Punjab. (Domicile Certificate in such cases is to be submitted to the College office along with application for admission.)

A student from any of the aforesaid categories shall have to furnish to the College an affidavit, duly attested by the local Executive Magistrate, on a stamped paper deposing his/her entitlement to take up Basic Punjabi/PHC in lieu of General Punjabi, at the time of admission.

Note: The Principal reserves the right to levy a uniform cess for meeting expenditure on unforeseen and emergent development projects of the College.

# Eligibility Conditions for Under Graduate Classes

B.A./ B.Sc. (Medical, Non-Medical, Economics, I.T., Computer Science) / DCA B.Com. / B.Com. (Hons.) / BBA

Only those students shall be eligible for admission to Semester -I Class who have passed:

- I) Senior Secondary Certificate Part II Examination of the Punjab School Education Board with minimum of 40% marks except for B.A.
- ii) Any other examination recognised as equivalent to the aforesaid examinations of GNDU, if he/she fulfils other conditions such as combination of subjects and/ or minimum percentage of marks required for that examination.

#### Notes:

A candidate for B.A./B.Sc. Sem. I Examination shall not opt for Physics, Chemistry, Maths, Botany, Zoology unless he/she has qualified in the same subject in the qualifying examination. A candidate for B.A./B.Sc. Sem. I Examination opting for Maths, Physics, Chemistry, Botany, Zoology without having qualified it at the qualifying examination may be allowed to qualify it in that/those subject (s) of the lower examination at the Supplementary Examination held in Sept. of the year of admission to the class. If he/she fails to qualify in that/those subject (s), his/her admission to B.A./B.Sc. Sem. I class shall stand automatically cancelled and he/she shall have no claim, whatsoever. A candidate shall opt for the same elective subjects in Sem. I to VI of B.A./B.Sc.

The students who pass Senior Secondary Part-II Examination with compartment(s) in a subject(s) will be admitted in the degree classes only after the rules and regulations are laid down by GND University for the current session.

#### **General Instructions for the courses under Semester System**

#### I. Courses having Two Semester duration:

- a. There shall be no condition for promoting a student from first semester to second semester.
- b. In case a student fails to pass all the courses/papers within a period of two semesters (One Year), he/she shall be given two consecutive semesters (one year) more to pass.

#### II. Courses having Four Semester duration:

- a. There shall be no condition for promoting a student from first semester to second semester.
- b. However, the student shall be promoted to the third semester only if he/she has passed at least 50% course / papers of the first two semesters.
- c. There shall be no condition for promoting a student from third semester to fourth semester.
- d. In case a student fails to pass all the courses/papers within a period of four semesters (Two Years), he/she shall be given four consecutive semesters (Two Years) more to pass.

#### III. Courses having Six Semester duration:

- a. There shall be no condition for promoting a student from first semester to second semester.
- b. However, the student shall be promoted to the third semester only if he/she has passed at least 50% courses/papers of the first two semesters.
- c. There shall be no condition for promoting a student from third semester to fourth semester.
- d. However, a student shall be promoted to fifth semester only if he/she has passed at least 50% courses/papers of the first four semesters.
- e. The student shall be promoted to sixth semester only if he/she has passed all the papers of the first semester. After a period of six semesters, the student shall be given a period of two consecutive years to pass.

#### IV. Courses having Eight Semester duration:

- a. There shall be no condition for promoting a student from first semester to second semester.
- b. However, the student shall be promoted to the third semester only if he/she has passed at least 50% courses/papers of the first two semesters.
- c. There shall be no condition for promoting a student from third semester to fourth semester.
- d. However, a student shall be promoted to fifth semester only if he/she has passed at least 50% courses/papers of the first four semesters.
- e. The student shall be promoted to sixth semester only if he/she has passed all the papers of the first semester.
- f. The student shall be promoted to seventh semester only if he/she has passed all the papers of first two semesters.
- g. After a period of eight semesters, the student shall be given a period of two consecutive years to pass.

# **Eligibility Conditions for University Examinations**

The University examination in a particular class shall be open to any student of an affiliated college provided he/she produces the following certificates signed by the Principal of the affiliated college last attended by him/her:

- i) of having remained on the rolls of an affiliated college for the academic year preceding the examination;
- ii) of having passed, one academic year previously, the lower (qualifying) examination of Guru Nanak Dev University or any other examination recognised by GNDU as equivalent thereto with the requisite percentage of marks and/or combination of subjects required under relevant ordinances.
- iii) of having attended not less than:
  - a) 75% of the total lectures delivered to his/her class in each of the subjects offered to be counted up to the last day when the classes break up for preparatory holidays.
  - b) 75% of the periods assigned to practical work in each Science subject. In the case of Geography, minimum number of periods required to be arranged by the college for practical work (Map work etc.) shall not be less than 40 in each subject.
  - c) 75% of tutorials in the case of B.Com.
- iv) of having obtained:
  - a) 25% marks in aggregate of all subjects or 20% marks in each individual subject in the House Examinations.
  - b) 30% marks in aggregate in a special test on request by defaulting/failing students with a special exam fee of ₹ 1000.00 in each semester.

#### **Change of Subjects**

A student may, with the permission of the Principal, change his/her combination of subjects by paying ₹ 200/- administrative charges for subject change and ₹ 500/- for faculty change within 15 days of the commencement of classes, after which no change will be allowed.

#### Withdrawals

- 1. Unless a student withdraws his/her name by presenting an application in writing, counter signed by his/her parents or guardian, before the expiry of a month after commencement of classes, he/she shall be liable to pay all his/her dues for the following month.
- 2. The name of a student will be removed from the rolls of the College:
  - a) For continuous absence without leave for 15 days or more
  - b) If his/her dues remain unpaid up to the last day of the month
  - c) For any act of indiscipline or misconduct

# **Payment of Dues**

- 1. The following schedule will be observed for the payment of fees:
  - I) 1st Instalment......At the time of admission
  - ii) 2nd Instalment (Along with University Exam. Fee)......October, 2021
  - iii) 3rd Instalment (Along with University Exam. Fee) ......January, 2022
  - iv) 4th Instalment......April, 2022
- 2. All fees and other dues must be paid on the dates specified, after which a fine of ₹ 20/- per day will be charged.
- The names of the students whose dues are in arrear at the end of a month are liable to be struck off the rolls at the
  beginning of the next month. Such students will be re-admitted on payment of their dues along with the
  re-admission fee.
- 4. Absence from college, with or without leave, will not be accepted as an excuse for non-payment of fees on the due date. Dues will be accepted from absentees when sent by M.O. or by Indian Postal Orders or by Bank Draft.
- 5. Fees and fines once paid will not be refunded.
- 6. Students, whose dues are in arrear, will not be issued character or other certificates until the dues are cleared. This applies to old students also.

#### Casual Students

The Principal generally does not admit such students. However, a limited number of students may be admitted as casual students. Casual Students will be required to pay their dues for the full academic session in advance at the time of admission.

Casual students pay no library, games or other fees and are not allowed any of these privileges. They are, however, subject to the same general rules of conduct and discipline as are applicable to regular students. They are not eligible for any prize, whether academic or athletic. They must deposit the certificates along with their admission applications for onward transmission to the Director, Public Instructions (Colleges), Punjab.

# **Scholarships, Donations & Grants**

All scholarships are subject to the holder's good conduct and progress in studies and these will be forfeited or withdrawn in the event of misbehavior, failure in House Examinations or failure to pay dues in time or for taking part in a strike or any other subversive activity.

- 4. It is the duty of each parent/quardian to know the performance of their wards in the house test and regularity in the class-room from time to time.
- 5. It is the duty of the parents to see that their ward(s) adhere to the college rules and fulfill the eligibility conditions for appearing in the final examination of GNDU.
- 6. It is the duty of the parents to attend Parent-Teacher-Meet to know their ward's progress.

Keeping in mind the pandemic of COVID 19, you are also requested to ensure that:

# Special Aid to Scheduled Castes Students under Post-Matric Scholarship Scheme.

The objetive of the scheme of "Post Matric Scholarship to Scheduled Castes Students" (Centrally Sponsored) is to provide financial assistance to students studying at post matriculation or post secondary stage to enable them to complete their education.

Scholarship will be paid to the students whose parents'/quardians' income from all sources does not exceed Rs. 4,00,000 /- (Rs. Four Lac only) per annum. The value of scholarship includes the following for complete duration of the course:

(i) Maintenance allowance

(ii) Reimbursement of compulsory non-refundable fees

(iii) Study tour charges

(iv) Thesis typing/printing charges for research scholars

(v) Book allowance for students pursuing correspondence (vi) Book bank facility for specified courses courses

(vii) Additional allowance for students with disability for the complete duration of the courses as per the provision of the scheme.

An income declaration by the self-employed parents/guardian, stating definite income from all sources by way of an affidavit on judicial stamp paper is required. Employed parents/guardians are required to obtain income certificate from their employer, and for any additional income from other sources, they are to furnish declaration by way of an affidavit on judicial stamp paper. Thereafter, concerned institutions will apply to the Welfare Department through their respective implementing department, for reimbursement of the fee giving an affidavit in this context that they have not charged compulsory non refundable fees from the students and the students included in the list have attended the institution regularly. The Welfare Department will reimburse the Admission Fee/ Tuition Fee and compulsory nonrefundable fees admissible under the scheme directly to the student through Online Banking Management System after the receipt of funds from the Govt.

**Note**: The prescribed application forms, which are required to be submitted by students seeking Government Scholarship/Stipends under the aforesaid schemes, can be had free of cost from the College Office or online from www.punjabscholarship.gov.in. Such students must submit their application forms, complete in all respects and supported by Scheduled Caste/Backward Class, Income/Domicile Certificate in the college along with their admission applications for onward transmission to the Director, Public Instructions (Colleges), Punjab.

#### **Fee Concession**

The College is very liberal in granting fee concessions to brilliant as well as needy students. Fee concession shall automatically stand withdrawn if the student fails in any subject in the House Examinations, or on grounds of misbehaviour/misconduct or for shortage of lectures. The concession offered to students on any basis is applicable only to the year of application, and is subject to change in the following year if the required conditions are not fulfilled. All benefits offered will be automatically forfeited if the student leaves college mid session or fails in the House Test/ Final Exams.

## Students' Aid Fund (SAF)

This fund exists for helping poor and deserving students with fees and books. Thousands of rupees from this fund are annually disbursed to the needy students. There are also other sources of financial help available to deserving students.

#### **General Rules**

- 1. Every student on the rolls of the College shall abide by the rules of the College framed from time to time, and shall strictly obey all the directives issued. Students are advised to read the College Notice Board daily.
- 2. If a student, during his/her stay in the College, is considered undesirable for any reason, his/her name will be struck off the College rolls by the Principal whose orders are final in this connection. The Principal has the right of removing the name of a student from the rolls of the College even without assigning any reason.
- 3. All students must keep their Identity Cards with them in the College. This is a must and defaulters are liable to be fined heavily.

#### Leave Rules

- 1. Leave should be applied for, and got sanctioned in advance, except in emergencies when it should be applied for on the day the student resumes studies at the College.
- 2. An application for leave up to four days should be presented personally to the tutor. When leave is granted, the application should be handed over in the office to be filed. The student should keep with him/her, for record, the counterfoil duly signed by the clerk-in-charge. In exceptional cases, applications may be sent by post under registered cover by name to the Principal.
- 3. No leave can be granted for an indefinite period. Leave for a period of five or more days should be applied for to the Principal personally with the tutor's recommendation.
- 4. In case of long illness, the application must be accompanied by a certificate from the College Medical Officer.

  Note: In case of error in the calculation of fine for absence, counterfoil of the leave application form signed by the clerk-in-charge will be considered the conclusive proof.



# **House Examinations**

- \* No student will be exempted from the Examination.
- \* Absence (with or without leave) from House Examination will be counted as failure.
- \* Leave from the House Examination will be granted only by the Principal on medical grounds only.
- \* Leave on medical grounds must be supported by a certificate from the College Medical officer. (Such students will have to appear in a special test.)
- \* The answer book of a student found guilty of using unfair means in a particular paper in the house examination reported by the Supdtt. to the Controller of Examinations shall not be assessed. The student will be deemed to have obtained no marks in that paper.





#### **House Tests**

- 1. Prizes shall be awarded for all subjects.
- 2. A prize winner should have passed in all the compulsory and elective subjects so as to be eligible for a prize even in one subject. Exemption from this rule is not allowed on any ground.
- 3. To be eligible for the First Prize in a certain subject, the student must have scored at least 60% marks in aggregate of the subjects in the house tests. However, in the case of M. Sc./ M.A./M.Com. students, the score has to be 55% or above.
  - Note: For M.A., M. Com. & M.Sc. students, each of the papers will be considered as separate subject.
- 4. If, in a certain subject, no student qualifies for the First Prize as per rule No. 3, then only a Second Prize will be awarded
- 5. To be eligible for the Second Prize in a certain subject, the students must have scored at least 55% marks in aggregate of the particular subject in the House Tests.
- 6. The Principal can use his discretion in awarding any prize if he considers a certain candidate deserving otherwise.





# **Prizes for University Examinations**

Students standing First in the College in their respective classes in various subjects and placed on the merit lists are to be awarded prizes as detailed hereafter:

- I) a) If a student is placed on the merit list and stands first in the College in his/her class, he/she is to be awarded a medal as well as a prize of the value of the First Prize.
  - b) Those who are placed on the merit list are only to be awarded a prize each of the value of the First Prize.
- 2. Prizes are to be awarded for all the regular Graduate and Post-Graduate classes.
- 3. The above prizes are awarded at the Annual Prize Distribution Function of the College.

#### **Prizes for Games and Athletics**

Students distinguishing themselves in various games and athletic events are awarded prizes at the College Sports Function which, during normal circumstances, is held once a year.

### **Roll of Honour**

The Roll of Honour (Academic) is the highest honour conferred by the College on its students for their excellent performance in the academic field. In order to be eligible for admission to the Roll of Honour (Academic), a student must have :

- i) a consistently good academic record;
- ii) appeared and passed in all his/her subjects in the House Examinations;
- iii) secured at least 75% marks (if the student has taken up Science Group) or 70% marks (if the student has taken up Arts or Commerce Group in the House Examinations) and
- iv) a good moral character.

  (The Principal has the discretion to make any alteration in or addition to the rules and conditions given above.)









## **Fines**

- 1. In case of absence from the College without obtaining proper leave thereof a fine of ₹ 1.0 per period but not exceeding ₹ 5.00 per day will be imposed on the student. A fine of ₹ 5.00 is charged for absence from a Science Practical, Composition period, Physical Training Class, Group Meeting, N.C.C. Parade or N.S.S. Programme. A special and heavier fine may be imposed by the Principal for any type of absence or an act of indiscipline or misbehaviour.
- 2. Absentee and examination fines are not remittable.
- 3. Use of unfair means during examinations or an act of indiscipline/misbehaviour is punishable by a special fine.

## **Medical Aid**

The College Medical Officer is available to students every day in the College premises during specified hours. The medicines available in the College Dispensary are supplied free of charge. There is no consultation fee.

Note: Only such medicines are to be supplied to the students as prescribed by the College Medical Officer and are available in the College Dispensary.



# Library

- 1. The College Library is housed in a spacious building. It has over 40,000 volumes on its shelves. The Reading Room gets a number of Dailies and Weeklies in English, Hindi and Punjabi. Every student, on admission in the College, is supplied with a Diary-cum-Identity Card for which a charge of ₹ 50/- is made. Students are required to submit one copy of their photograph (passport size) along with name. This I-card, if lost, can be got reissued on a payment of ₹ 250/-. Students are required to get their I-cards issued within a fortnight of their admission, failing which they are liable to be fined ₹ 20/-. Borrower-cum-Identity Cards and library books are not transferable under any circumstances. Students are required to carry their Diary-cum-Identity Cards with them and produce it on demand by the College Staff, failing which a fine up to ₹ 50/- can be imposed.
- 2. Borrowers will be divided into the following categories and shall be entitled to draw at a time the number of books mentioned against each category:
  - i) Under-Graduate Students ......Two ii) Post-Graduate Students .....Four
- 3. Borrowers are to return the books within fourteen days from the date of issue even if he/she is on leave. A fine of ₹ 2/- per day per volume is charged if books are not returned by the due date. If that day happens to be a holiday, books must be returned on the next working day, failing which fine will accrue for all the days books are overdue.



- 4. Books for which there is a great demand will be issued for a shorter period. Delay fine for each such book shall be ₹ 2/- per day per volume. If a book is lost, not only the price of the book but also the delay fine will be charged.
- 5. Books will be received and issued on all working days usually from 10.00 A.M. to 1.00 P.M.
- 6. Borrowers are expected to examine the books at the time of borrowing. If a book is damaged, the fact should be brought to the notice of the Librarian at the counter, otherwise the responsibility will be that of the borrower.
- 7. Reference books and periodicals are not issued to students. These can be read in the College Reading Room only.
- 8. Books issued to students may be recalled at any time on two days' notice.
- Borrowers are responsible for the safe custody of the books taken out by them. Books lost, defaced or otherwise damaged, shall be replaced at the borrower's cost. In the event of such a book being one of a set, the borrower will have to replace the whole set or series at his/her cost
- 10. The library is open for students from 10.00 A.M. to 1.00 P.M. during vacations..

## **National Cadet Corps (N.C.C.)**

- 1. The College maintains one platoon of N.C.C. infantry where training is provided to the students.
- Those who do good work, keep good turn-out and are regular in attendance throughout the year are given promotion in rank. Members of the N.C.C. get uniforms and refreshments free of cost.
- A student once enrolled as a cadet is expected to continue in the Corps for two years to enable him/her to get 'C' Certificate.

## National Service Scheme (N.S.S.)

The College has been allotted two units of N.S.S. (100 students each, one for boys and the other for girls).

- 1. Those who take up NSS have got to abide by its rules and regulations as stipulated by the University from time to time.
- 2. It is a must for the students opting for N.S.S. to put in 120 hrs. of social service including the Summer Camp and they will be awarded certificate for the same.
- 3. Outstanding volunteers in N.S.S. will be awarded V.C.'s certificates.

### **Career and Counselling Cell**

To provide guidance to students in the choice of careers and courses of studies best suited to their aptitudes, interests and other related factors, a Placement Cell is fully functional in the College. The Placement Cell also provides information about the facilities for higher, general and professional education in India and abroad, Scholarships, Fellowships, Apprenticeships, Research and Travel Grants, Competitive Examinations, Job Opportunities, Employment Outlook etc.

Students are advised in their interest to contact the Placement Cell personally before making a choice for their careers and courses of studies. The Placement Cell welcomes enquiries regarding the availability of professional occupations.

# **College Canteen**

The College Canteen supplies eatables at subsidized rates. There is a sub-committee of College officials specially organized to supervise the quality and rates of eatables and to maintain good hygienic conditions in and around the canteen.

# Scooters/Motor Cycles

1. Students bringing scooters or motor-cycles to the College are required to keep them locked at the College Cycle-Stand. The fees for scooters or motor cycles shall be as following:

Motor-cycle/Scooter/Moped ₹ 1200/- per annum

(Students are not allowed to bring four wheelers to the college)

At the time of surprise checking, anyone found without listing of vehicle in the College will have to pay full year's charges.

- 2. The scooter or motor cycle will be taken off the College list only after an application to this effect, recommended by the Prof. in-charge (Cycle-Stand), is finally accepted by the Principal. Failing this, the fee shall be chargeable for the full academic session.
- 3. The College authorities are not responsible for the loss of a cycle/scooter if the same is left unlocked and is not placed in proper custody of the security guard at the cycle-stand.
- 4. The College is not responsible for the loss of accessories.

Note: For Scooter/Motor Cycle annual charges will be charged with the fees
