- The payee shall exercise reasonable economy in expending the sanctioned amount.
- Regular accounts shall be maintained in respect of expenditure of the sanctioned amount.
- Immediately after the programme is over, the payee shall furnish the detailed statement of expenditure supported with original vouchers latest by one month after the programme.
- The payee shall submit a brief report of the programme along with a copy of the script of the Lecture delivered as well as 2/3 photographs with the background of banner/back drop etc.
- 7. If the event is not organized before 31st March, 2018 the sanctioned amount must be remided to the Council forthwith via D.D. in favour of iCPR, New Delhi.
- Apart from the taxi, an honorarium of Rs. 2,000/- for each lecture may be paid to the Resource Person/scholar who delivers the lecture of maximum up to three lectures.
- Organizational expenditure & Refreshment not to exceed Rs. 4,000/-
